New police chief refines SMPD hierarchy, goals

Not even one month into his appointment as St. Matthews' new Chief of Police, Barry Wilkerson began making changes to improve an already successful police department. Appointed in November 2017, Chief Wilkerson organized a "blitz" during the Christmas shopping season to prevent shoplifting.

"Shoplifting is a big challenge in our community, often committed by persons who want money to buy heroin and other drugs," he said. The December blitz called for area business loss prevention personnel to partner with the St. Matthews Police Department (SMPD) and the Louisville Metro Police Department (LMPD) using an application on their phones. The app allowed loss prevention personnel witnessing shoplifting in action to reach an SMPD officer patrolling near the store. This enabled SMPD to stop thefts in progress and store owners to lose less merchandise. The result was 27 arrests, \$82,324.81 in recovered property, and \$12,000 in seized narcotics.

Chief Wilkerson has also changed the hierarchy of the City's police department. SMPD has three sergeants who supervise the first, second, and third patrol officer shifts; a sergeant who supervises administration, including the vehicle fleet and communications; and a sergeant who supervises criminal investigations. Formerly, one major gathered information from all these sergeants and reported it to the chief so that the

chain of command was one line from the bottom to the top. Chief Wilkerson created a second major position.

Major Tony Cobaugh heads up the Operations Bureau, including the Patrol Division, Special Response Team, and Training Division. Major David Beyer is in charge of the Support Bureau, including the Administrative Unit, Vehicle Fleet Operations, Telecommunications, the Property Room, and the Criminal Investigation Division. This hierarchy allows for more than one viewpoint before information reaches the top and adds an extra person to the Executive Command staff.

Besides changing the department's line of command, Chief Wilkerson has goals to improve the professionalism of the department and to become more proactive in addressing crime trends. "Chief Mayer did a great job getting the department where it is now, and I want to make sure we are held to the best standards and procedures being used nationwide," he said. In fact, Chief Wilkerson is writing an updated Standard Operating Procedure for the department to reflect current police best standards and practices.

An example of a best practice procedure that will be included in the handbook is the Double Blind Administered Photo-pack. This nationwide best practice requires the detective showing photo-packs to witnesses to be "blind" to who the suspect is, creating a more equitable process.

A Message From...

Annual City audit completed

Results of the financial audit for fiscal year 2016-2017 proved the City of St. Matthews continues to maintain the strong financial position it has sustained for decades.

The audit, conducted by the accounting firm, Stephens & Lawson, CPAs, resulted in a clean opinion indicating no malfeasance or mismanagement of public funds.

During the last audit year, both assets and liabilities have risen. The increase in liabilities is chiefly due to the pension funding burden created by the Kentucky Retirement Systems. Even though the City of St. Matthews has paid what it owed, every government agency participating in the Kentucky Retirement System is being held liable for contributions that were not made by the state. The liability is required to appear on each audit, although payments are not required to be made at this time.

Despite this misleading liability, the audit firm reiterated that the City of St. Matthews retains its longstanding solid financial condition. Current assets include approximately 75% of the revenues collected from occupational and property taxes during the 2016-2017 fiscal year.

The 2017 audit, as well as the 2018 City budget and Ad

Building or expansion requires permit

Are you planning to build or expand? Building permits for Jefferson County are issued by the Louisville Metro Department of Inspections, Permits and Licenses (IPL), which can be reached by telephoning 502-574-3321.

Please note that a Letter of Compliance is required from the City of St. Matthews before a permit will be issued. There is no charge for the letter. To obtain a Letter of Compliance from the City, you must provide to the City Engineer the following documents:

- A completed application for the Letter of Compliance, available at the City Administrative office, on the third floor of City Hall or online at www.stmatthewsky .gov/letter-of-compliance/.
- The name and address of any contractor or subcontractors who will be working on the

project. All contractors and subcontractors must have a current City of St. Matt-



hews business license before a Letter of Compliance can be issued.

 Two copies of the site plan, which is a scaled drawing of the property showing any existing buildings (including parking spaces) and the newer proposed building.

> Please note that interior remodeling projects do not require a site plan, nor are property owners, who are performing the work themselves, required to have a business license.

Second assistant chief appointed

On January 1, 2018, St. Matthews Police Officer Anthony J. "Tony" Cobaugh was appointed to Major, Assistant Chief of Police, and also the Operations Bureau Commander. His bureau includes the patrol, SRT, and training divisions. Major Cobaugh joins Assistant Chief was appointed as the training director. In addition, he has served as the Special Response Team commander, special events coordinator, adopt-aschool coordinator, quartermaster, and health and safety officer for the SMPD.

Major Cobaugh was hired by the St. Matthews Police Department in July 2011. He

(basic, in-service, and supervisory) training program, which is still in operation today. He became a Kentucky Law **Enforcement Council** certified police instructor in January 1980.

Major Cobaugh was hired as a police officer for the Jefferson County Police Department in 1982. He served in the patrol, investigations, academy, and street-level drug enforcement sections and was promoted to sergeant and lieutenant. He began serving on the SWAT

team in 1986 and was awarded the police medal of honor in 2002.

He joined the Louisville Metro Police Department in January 2003 and served as the commander/assistant commander in patrol, internal affairs, basic training, and the special operations sections. He was appointed as the SWAT team commander in 2007 and retired in 2011 before joining the St. Matthews force.

Cobaugh is a past president of Jefferson County FOP Lodge #14 and the past president of the Kentucky Tactical Officers Association (KTOA).

Your Works at Work

Hopefully Mother Nature will repeat the weather from 2017, and we will have another mild end to the winter season. If not, our snow crews are on standby and ready to give their best efforts for what may come our way.

Since the last newsletter, the following work has been accomplished:

Completed Projects:

- Activated the City's snow and ice removal program during two measurable snowfalls. All major roads—Shelbyville, Westport, Hubbards, Browns, Bowling, and Breckenridge are the responsibility of Louisville Metro and the Commonwealth of Kentucky.
- Spot drainage improvement on Elmwood Avenue
- Set up for Christmas in Brown Park and installed decorations throughout the City

 Finalized a joint drainage project with MSD at Kentucky and Washburn.

Current Projects:

- Removing damaged ash trees and replacing them with flowering trees along Bowling Boulevard
- Cleaning up landscaped areas, re-mulching, and planting about 150 trees in the three major parks and the City
- Construction that began November 2017 on City Hall and the library is expected to be completed in four phases. Phase One includes installation of geothermal wells, the foundation, and steel for the new library, as well as renovating the police squad room and associated offices. Phase One is expected to be completed in April 2018.

- Putting in sidewalks on Massie (between Ridgeway and Hubbards)
- Street sign replacement north of Massie.

Future Projects:

- Spot drainage improvements on Winchester
- Spot drainage improvement at Hycliffe and Breckenridge
- Phased street sign replacement project throughout the City
- Possible road widening of Primrose from Dellridge to Westport
- Bathroom and playground improvements at Brown Park.

Hot Off the Press

Update on ambulance service



It's been more than a year since the St. Matthews Fire and Rescue ambulance service has been in operation. The paramedics and EMTs responsible for the Advanced Life Support Ambulances average 17 service calls a day and have cut response time in half for calls in St. Matthews. Due to proximity, what used to take Louisville Metro EMS nearly 10 minutes now takes the St. Matthews crews an average of 5 minutes to arrive on scene with less than one minute initial response time.

The St. Matthews Fire Protection District was the first district in Jefferson County to establish ambulance operations as part of their mission to protect the public. Several other districts keep the parks beautiful by following these simple rules:

- Pick up any trash and dispose of it in the nearest trash basket
- Report any damage or irregularities to City Hall
- Keep pets on leashes, and pick up after your pet.

Clothes dryer fire safety

The U.S. Fire Administration reports that more than 2,900 home fires are started by clothes dryers annually. The leading cause of these fires is a buildup of lint due to lack of simple maintenance on the part of the owner.

Lint can be trapped in crevices deep inside the lint filter trap and all along the dryer vent hose or duct, as well as building up on the heating element, causing the dryer to overheat and possibly catch fire. As a rule, a fire starts from a spark in the machine. However, improper clothes dryer venting practices outside the dryer can play a key role in this process.

Here are some warning signs of dangerous lint buildup:

- Clothes take longer to dry
- Clothes are hotter than normal at the end of the drying cycle
- Exterior of the dryer gets very hot

- Outside exhaust vent flapper does not open much
- Laundry room becomes more humid than usual
- Burnt smell is evident

Maintaining clothes dryer safety to prevent a house fire requires the following three steps: (1) Clean the lint filter before/after each load of laundry. Don't forget to clean the back side of the dryer exterior where lint can build up. (2) Clean out the dryer vent duct behind your dryer every three months. Use a large dryer duct vent brush to clean out the duct. Move it carefully, spinning it slowly while you push it in. Pull it out slowly and remove the lint from the brush. (3) Have your dryer cleaned regularly by a professional, especially if it takes longer than normal for clothes to dry. These steps will help you keep your clothes dryer and home safer.

Snow removal tips



After any significant snowfall, all city streets are cleared. Naturally, the main thoroughfares receive attention first; once they are cleared, all residential streets are systematically treated.

During this time, we ask that all vehicles be parked off of the roadways to allow the snow plows to maneuver safely and properly clear your street.

In the winter, trash cans left outside may ice up. Make sure there are lids on them so they don't fill with snow. Rumpke will not pick up iced over containers or containers with garbage frozen to the can.

After heavy snowfalls and when sidewalks are icy, St. Matthews residents must move garbage and recycle cans out to the street for pickup. And last, but not least, please be a good neighbor and clear the sidewalk in front of your home.

Report potholes and damaged areas

The mayor and council members of the City of St. Matthews would like to thank you for taking the



time to report a pothole or visual damage to a city street. It is important for these issues to be inspected, documented and corrected as the situation dictates.

To report a pot hole, use the Call make a huge mess. They are St. Matthews 24/7 Information System by telephoning 502-498-CALL (2255), option 2. Please give the street name and closest business or residential address to the pothole or damaged area being reported. If you would like to be contacted, please leave your name and daytime telephone number, along with the best time to reach you during the day.

Free services for stray cats

Feeding stray cats? Alley Cat Advocates can help get outdoor cats fixed and vaccinated at no cost to you. As part of Alley Cat Advocate's Trap-Neuter-Return program, the cat will be vaccinated, spayed or neutered, treated with flea and ear mite medicine, examined by a vet, and ear-tipped (the universal symbol of a neutered cat).

Coyotes in neighborhoods

Coyotes are becoming more common in urban areas and St. Matthews is no exception. As their habitat gets smaller and their numbers increase, coyotes are forced to live near humans to get food and shelter.

Coyotes play an important role in keeping the rodent population controlled, but they will also snack on your family pet if given the opportunity. Coyotes will break into your garbage cans and mainly active at night. Their howls are loud and irritating, particularly in the mating season.

If you have coyotes lurking around your backyard, try the following suggestions to become "coyote free" in no time.

 Take away their food sources. Stop feeding dogs and cats outside so a coyote cannot steal the food from your porch at



night. In addition, secure trash cans in your garage or a shed.

- Reduce your rodent population. The best way to do this is to keep your property clean and free of food sources, like garbage or grains.
- Keep your yard well maintained. If the grass is cut short and bushes are trimmed, you take away the opportunities for shelter where coyotes feel safe to sleep during the day.

Code Words

Illegal parking has become one of the top complaints received by the City of St. Matthews Code Enforcement Department.

No vehicle may be parked in the front yard at any time, except on a legal driveway. A properly permitted "pull off" located totally in the right-of-way is allowable. To learn which areas in St. Matthews prohibit parking, residents may contact City Hall.

Vehicles parked along the rightof-way should follow these rules:

- A vehicle must be parked heading in the same direction as the traffic on that side of the street.
- A vehicle parked along a road must have its right-hand side parallel, not perpendicular to or at an angle, with the curb or edge of pavement.
- The vehicle may not be parked so as to create an impassable obstruction of the roadway.
- The vehicle must be at least 30 feet from any stop sign or

corner on either side of the street.

 No vehicle may be parked anywhere so as to impair the free use of a public



sidewalk, even partially.

A vehicle may be parked on the street for no longer than 24 hours at a time in the same location.

The impairment of public sidewalks is another significant issue throughout the City. In addition to vehicles being parked completely across a sidewalk, often a vehicle is parked so that



the bumper or other the vehicle partially blocks the sidewalk.

The Ameri-cans with Disabilities Act requires the City to make every effort to ensure that the entire width of the sidewalk is kept free from obstruction.

As a general rule, no more than four passenger vehicles may be parked outside in the driveway and on the right-of-way in front of a residence. Any vehicle that is not a passenger vehicle may not be parked at a residence.

Further, zoning regulations allow only one medium truck to be parked on a residential lot. A medium truck is a truck or similar vehicle (other than truck trailers) with a single rear axle and dual rear wheels. It must be parked in the driveway, not on the street.

Any infraction of the rules previously stated in this article can result in the issuance of a extension of citation. For the sake of your neighbors and St. Matthews visitors, be courteous and follow the rules.
