Whether you are a child enjoying the playground at Brown Park, a physically challenged business owner navigating friendly side-walks, or a visitor to St. Matthews following carefully placed street signs, you are benefiting from the labor of the City's Public Works Department. Study the faces in the photo above and read about each crew member's role in the

department to become familiar with the men who work daily on your behalf.

Terry Ridgeway has earned the title, "Mr. St. Matthews" through hard work and dedication. Terry is the pulse of the Public Works Department, developing and supervising the daily schedules of his crew.

Dave Hill puts in plants in the parks, mulches, weeds, does leaf pickup, and operates the water truck to irrigate the plants.

Ray Wheeler, "The Chatty Custodian," is responsible for cleaning City Hall. He always greets people

Construction on City Hall, Library on schedule



The SMPD squad room was completed during Phase I of construction.

Construction is nearly complete on Phase II of the four-phase project to renovate City Hall and enlarge the St. Matthews-Eline Library.

Phase I, completed in April 2018, included renovating the St. Matthews Police Department squad room, putting in a geothermal system, and erecting the steel for the Library addition,

which has been fire-proofed. SMPD has occupied its new squad room, workout room, and offices. Office space includes two interview rooms, a holding cell, a detective space, and offices for four sergeants, two majors, and the police chief.

Phase II, which includes renovating the second floor of City Hall, putting a new roof on City Hall and

A Message From...

Budget approved

A budget totaling \$19,831,562 was approved by the City of St. Matthews for fiscal year 2018–2019. It includes a 3% increase for garbage, yard waste, and recycling expenses, as well as funding for numerous public works projects in the City.

Projects included are sidewalks on Massie Avenue, improvements to Primrose Drive, permanent restrooms at Brown Park, and vast improvements including expansion of the children's playground at Brown Park.

It also includes 5 new police vehicles and 15 new computers. The Kentucky Retirement System is requiring an additional percentage amount to be paid each month in order to stabilize the System.

Tax rate soon to be set

This year's *Ad Valorem* tax discount will be determined by City Council vote in September after the Jefferson County Property Valuation Administration has released official assessment figures in late August. The tax is payable in November or December, but those who pay before October 31 will receive the discounted rate.

Tax bills will be mailed by October 1. Residents who do not receive their bill at that time or who have questions about their tax bill should contact City Hall as soon as possible at 895-9444.

LG&E working on busy streets

LG&E is working on a 13 kilovolt reconductor project in the heart of St. Matthews replacing poles and installing larger conductors to provide increased capacity for the area.

Crews will be working for the next 3 to 4 months on Breckenridge Lane, Shelbyville Road, Frankfort Avenue, and Lexington Road.



City Hall prescription drug drop-off closed during construction

During the current construction and renovation project on the City Hall campus, the prescription drug drop-off box outside the St. Matthews Police Department in City Hall is regrettably unavailable. That does not mean you need to start flushing the drugs down your sink or toilet.

Wastewater treatment plants are designed to treat the dirty water that goes down toilets and sinks, but they are not intended to treat and remove medications. When medications are dissolved into wastewater, they may be unintentionally discharged back into waterways.



Flushing unused or expired medications down a toilet is a guarantee that they'll end up in the water supply. Even throwing them in the trash means they will likely end up in a landfill and eventually contaminate the groundwater, leading to medication contaminations of lakes, rivers, and streams.

To avoid this contamination while the City Hall renovation is being completed, the City suggests you safely dispose of medications at two 24-hour Walgreens stores: 2021 Hikes Lane (451-0931) and 12101 Shelbyville Road (244-7037).

Both stores have installed a Safe Medication Disposal Kiosk. Individuals can safely dispose of their unwanted, unused, and expired medications at no cost. Simply deposit the medications in the kiosk—like dropping a letter into a mailbox. The kiosks are located next to the healthcare clinic in each store.

The types of medications accepted include prescriptions,

prescription and over the counter ointments and creams, liquids, lotions, pet medications, prescription patches, over-the-counter medications, and vitamins. Certain medications are not accepted at the kiosks including needles, inhalers, aerosol cans, hydrogen peroxide, thermometers, and illicit drugs.





Recycling is collected every other week on the same day as trash on weeks highlighted in red. Holidays are marked in blue and will delay recycling and trash one day.

New safety initiative with AAA

The SMPD, in partnership with AAA East Central, McDonalds Restaurants of Kentuckiana, and Bike Louisville are launching a new initiative entitled "Helmet Smart." This program rewards children for wearing a helmet while riding a bicycle and provides bike helmets to children financially unable to purchase one.

Under this initiative, a St. Matthews Police Officer can issue a "Safety Citation" to a



child wearing a helmet while riding a bicycle. This Safety Citation rewards the child for being safe by providing a coupon for a free Happy Meal at McDonalds. In addition, the child can use the citation form to enter a drawing for a free bicycle, which will be given away by AAA Kentucky.

As part of this initiative, the SMPD received 100 bike helmets from Louisville Metro and Bike Louisville to give to underprivileged children who do not have bike helmets.

The SMPD extends its appreciation to AAA of Kentucky, Louisville Metro, Bike Louisville, and McDonalds for their assistance with this important safety initiative.

New KY driver's license law begins in 2019

In 2017, the Kentucky General Assembly passed a law that will bring major changes to Kentucky's driver's license and personal ID card programs and enable Kentucky to meet new security requirements issued by the federal government. These new requirements affect things like boarding domestic commercial airline flights within the U.S. and entering restricted federal facilities.

A new Voluntary Travel ID will be available January 1, 2019. It will be just like a driver's license or identification card, but will include a mark to indicate it is federally

compliant. A person won't need both a license and a Voluntary Travel ID—the federally compliant Voluntary Travel ID will also function as a license. The standard driver's license will only be acceptable for driving a vehicle.

After filling out the appropriate forms at your license branch, the new Voluntary



Travel ID, personal ID card, or standard driver's license will be mailed to you. A temporary license or personal ID will be issued for use until you receive your permanent one.

To be issued a Voluntary Travel ID, a personal ID, or a standard driver's license, you will have to present two pieces of mail to provide proof of residence and two of the following: your certified birth certificate, Social Security card, or U.S. Passport.

Beginning in 2019, the Voluntary Travel ID will cost \$48 and be valid for 8 years. The standard driver's license will cost \$43 and be valid for 8 years. The Voluntary Personal ID Card will cost \$28 and be valid for 8 years. The standard personal ID card will cost \$23 and be valid for 8 years.

Crime Buzz

Drive sober or get pulled over



The St. Matthews Police Department has been awarded a six-

month grant from the Kentucky Office of Highway Safety which will focus on seatbelt violations, speeding, and DUI. From August 17 through September 3, officers will focus on enforcing violations of alcohol-impaired driving. In 2016, there were 10,497 fatalities in the U.S. from motor vehicle crashes involving alcohol-impaired drivers. If you choose to drink and drive—and it is a choice—you risk not only your own life, but also the lives of innocent people in our community.

Look before you lock

Heat-related deaths are preventable. Please do not leave children or pets in a car.

According to the Cabinet for Health and Family Services, 39 children in the U.S. died from vehicular heatstroke in 2016 and 43 in 2017.

Statistics show that more than half of the children who died were simply forgotten and another 30% were

playing in a parked vehicle.

With an outside temperature of 80 degrees, the temperature inside your car can quickly become deadly: in 10 minutes –99 degrees; in 20 minutes –109 degrees; in 30 minutes –114 degrees; and in 1 hour –123 degrees!

If you see an unattended child in a car, call 911 immediately. In addition to children, mentally or physically disabled adults, and pets are equally at risk. The solution to preventing more deaths this year is to form the following new habits.

Four Lifesaving Habits

- Look before you lock the vehicle.
- Seat a child behind the front passenger seat.
- Leave your purse, briefcase, etc. on the backseat floor.
- Keep a stuffed toy in an empty car seat; then move the toy to the front passenger seat when a child occupies the car seat as a reminder that a child needs to be removed from your vehicle.

Car break-ins

It is the time of year when the City of St. Matthews experiences an increase in vehicle break-ins. These are crimes of opportunity. Please do not leave valuables in your car, especially in plain view. Remember to always lock your vehicle, too.



SMPD strongly urges all St. Matthews residents to sign up for Reach Alert to be contacted in an emergency. It just might save a life.

Solicitation ordinance

St. Matthews has a solicitation ordinance which states that persons may solicit between the hours of 9 a.m. and 7 p.m., Monday through Saturday. Solicitation is prohibited on Sunday and on state or national holidays.

All solicitors in Louisville Metro, which includes the areas in the City of St. Matthews, must have a peddler's license. Make it a habit to ask solicitors to see their IDs when they knock on your door. If they do not have this permit, or it is invalid, report them at once to the SMPD at 893-9000.

Proper fencing

While each neighborhood in St. Matthews has different setback requirements for buildings that affect fence locations, some general guidelines may be helpful in understanding the rules for fencing.

Any fence between the line of your house and a street cannot be taller than four feet, including posts or ornaments. This includes both streets on corner lots.

In addition, for the first 25 feet along each street from the property street corner, no fence may be taller than two feet. For any remaining areas, a

fence may be up to seven feet tall.

You may only place a fence on your property, and you will want to ensure that there is not a deed restriction on your lot that further limits fencing. The City does not have access to these details, which can be uncovered through a title search or through your realtor.



Good Neighboring

Watch for children

School begins Aug. 15. Please watch for children walking to school and waiting for buses.



You may not be able to see them behind other vehicles.

Make a special effort to watch for children crossing to board a bus, and do not go around the bus when its stop sign is extended. Obey the speed limit and school crossing guards. NO amount of hurry is worth a child's life!

Yard waste pickup

Yard waste in plastic bags is not collected. It must be placed in biodegradable bags or reusable containers. Free yard waste stickers are available at City Hall for reusable containers.

Mowing reminders

When mowing your yard, please aim the mower so that grass clippings do not blow onto the street, sidewalk, or your neighbor's driveway. Don't forget to take care of the grass alleyways adjacent to your yard. Keeping alleys mowed and trimmed is an important part of being a good neighbor. Some benefits of well-kept alleyways are:

- Better drainage
- Less rodents and other vermin
- Easier access for utility workers.

Remove your signs

If you post a temporary sign as a notice for a yard sale or regarding a lost pet, please remove the signs as soon as possible. Signs clutter the environment, hinder pole accessibility by utility workers, and are actually illegal.



Hot Off the Press

St. Matthews and Lyndon Fire Districts merge



The St. Matthews Fire Protection District and the Lyndon Fire Protection District are joining forces. After filing a joint petition with the Jefferson County Clerk's office to merge the two districts, the Lyndon and St. Matthews trustees approved the merger May 29 and June 6, respectively. A new board of trustees and the command staff of the two organizations are currently completing a review to consolidate budgets, policies, equipment, and personnel.

The Lyndon Fire Department was formed in November of 1949.



Although most of the area at the time was rural farmland, several members of the local community foresaw the need to provide some measure of protection for their neighbors. As a result, the Lyndon Fire Department was officially incorporated in January of 1950. Although they had no equipment,

the members began firefighter training with other departments.

In the early years, most money for the department was raised through door-to-door collections, fundraisers, and carnivals. The department also charged a "membership" fee to the residents in the area in order to help defray costs. In the 1970s, the department became a taxing district, generating revenue from property taxes.



The St. Matthews Fire & Rescue, as it is known today, filed articles of incorporation under the name St. Matthews Voluntary Fire Association on June 11, 1919. The words and actions of the founders inspired what was to become one of the most innovative and dedicated fire services in Kentucky. Evolving from a private association in 1919 to a special taxing district in 1984, the St. Matthews Fire Department now pays its firefighters and has grown its fleet from one fire truck to six trucks and three ambulances.

You can prevent fires caused by smoking

Every year, almost 1,000 smokers and nonsmokers are killed in home fires caused by cigarettes and other smoking materials.

One-in-four people killed in home fires is not the smoker whose

cigarette caused the fire. More than 30% are children of the smokers, and 25% are neighbors or friends of the smokers.

Fires caused by cigarettes and other smoking materials are preventable. You can make a difference!

If you smoke or live with someone who smokes, learn the facts. A lit cigarette accidentally dropped onto a chair or bed, and hot ashes or matches tossed away before they are completely out can cause

a large fire in seconds.

Putting out a cigarette the right way only takes seconds, too. It is up to you to make sure your cigarette is put out—all the way, every time.

Take these steps to prevent fires caused by smoking:

- If you smoke, always smoke outside.
- Wherever you smoke, use deep, sturdy ashtrays.
- Make sure cigarette butts and ashes are out.
- Never smoke in a home where oxygen is used.
- If you smoke, fire-safe cigarettes are better.



Library closing for renovation



Since the last newsletter, the following work has been accomplished:

Completed Projects

- Maintenance checks on all irrigation systems.
- Trimming, landscaping, mulching, and planting throughout the City.
- Street sign replacement in Cherrywood subdivision.
- Planting approximately 115 trees.

- Sidewalks on Elmwood.
- Debris removal from several severe thunderstorms.

- Street sign replacement north of Massie Ave.

Future Projects

- The design of drainage improvements along Winchester and St. Germaine has been budgeted.
- Phased street sign replacement project throughout the City.
- Possible road widening of Primrose from Dellridge to Westport Rd.

the Library addition, and the southern parking lot for the Library, is nearing completion. The second floor has been fully renovated with new HVAC, electrical wiring, ceiling


tiles, carpet, and paint. This will be the new home for City Administration and Public Works/Engineering and should be ready for occupation in August. During this phase,

electrical, plumbing, and HVAC systems are also being installed in the Library addition. The interior framing is almost complete and the roof should be finished by mid-July.

Phase III includes renovating the third floor of City

Hall, the existing Library, the front lawn of City Hall, the east parking lot, and starting renovation on the east side of the first floor of City Hall. Phase III is scheduled for completion by December 2018. (For information regarding the Library's temporary closure, see the Library article on page 9.)

Phase IV includes renovating the SMPD lobby on the east side of the first floor, constructing the Library entrance drive, as well as putting the finishing touches on the entire construction project. Phase IV is scheduled for completion in March 2019.
