# **Seasons Greetings**

With winter in full swing there are a few things that residents should know about their St. Matthews services.

When it snows in the city be sure to park your cars in the driveway rather than the street so that snowplows can move unimpeded through the streets. The City of St. Matthews completely clears and treats it's streets so you'll want to be sure that they can get through.

If you have storm damage and need to dispose of tree limbs,



place them at the curb edge and city crews will come by and haul them away. There is no specific schedule, but normally the crews make several trips through the city.

After heavy snowfalls and when sidewalks are icy, St. Matthews residents must carry their garbage cans, along with recycling container, out to the street for pick.

Residents please remember not to leave your car running when you're not in it. This practice invites thieves to take advantage of you and wastes gas that pollutes the air. In fact, its illegal.

The cost of home-heating fuels and utilities has caused many residents to search for alternate sources of home heating. All these methods of heating may be acceptable; however, they are

a major contributing factor in residential fires.

Many of these fires can be prevented. The St. Matthews & Lyndon **Fire Protection Districts** encourage you to follow these safety tips to maintain a fire-safe home this winter:

- 1. Never use fuel burning appliances without proper room venting.
- 2. Do not use flammable liquids

## **CODE Words**

As the cold weather settles in, we can anticipate the arrival of snowfall. While the depth of the snow usually varies by the event, accumulation of any depth on the sidewalks throughout the City creates a serious hazard for those using the sidewalks. St. Matthews has an Ordinance (92.02) requiring the occupant of property abutting a public street in the City to remove snow from the sidewalks in front of the



property within 24 hours after the fall of snow. This requirement is for the safety of everyone, and, when everyone does their part, what seems like a large task is accomplished with a little effort from all and not with a lot of effort by a few. Also, during the winter months we receive numerous complaints about trailers, campers, and boats parked or stored on residential property. The same rules that apply to commercial

vehicles, motor homes, and trucks also apply to trailers, campers, and boats. Ordinance 78.09 prohibits parking or storing any of these vehicles in any front or street side yard or on a private driveway of a residential lot between a line along the front of the building on the lot and the paved portion of the public street or on any street within a residential district.
