

IMPORTANT TAX INFORMATION!!!

Recently, you may or may not have received a notice from Jefferson County Property Value Administration (PVA). Effective January 1, 1992, the value of some property was reassessed. The City of St. Matthews has adopted the county assessment.

If you received a reassessment, you also received written material with instructions on what to do if you do not agree with the assessment. Please DO NOT call City Hall. We have no recourse in this matter.

Follow the instructions that were sent with the reassessment on when to call, where to call and what your alternatives are. If you think the reassessment is incorrect, you must appeal to Jefferson County.

Beginning this year, tax statements will be received in the fall rather than July 1. Your statement will cover the same time period, you will just receive them later. There will be more details concerning this matter in upcoming newsletters.

CLARIFICATION ON TRASH PICKUP

In an effort to clarify the agreement between the City of St. Matthews and Laidlaw Waste Company, please take a minute to read the following.

Every piece of residential property is allowed to have three (3) thirty (30) gallon cans that will be picked up in the rear of the property. In addition, the following items may be placed at curbing for collection on your regular day:

- leaves, grass clippings and sod in 32 gallon or less bags or cans
 - · other discarded items
- shrubbery and tree trimmings which are cut and tied in four-foot lengths

St. Matthews residents are responsible for ensuring that the bags or bundles weigh no more than 50 pounds each.

If any resident abuses these privileges, Laidlaw Waste Company will not discuss it with the resident but will notify the City Council. Under the Laidlaw Waste Company agreement, the pickup of trash and junk at times of normal pickup will be provided at no additional cost to the city. Individual residents may be charged up to \$5.00 per discarded appliance such as water heaters, stoves, refrigerators, etc...

House Number Ordinance


Sidewalks, Streetlights and Trees

We would like to remind all of our property owners that we will replace or establish a new sidewalk if you submit a petition from your block containing at least 51% of the residents of that block. The same procedure applies if you would like to have new streetlights on your block. If you would like to have a tree planted on the easement of your property an individual request is all that is needed

Stash Your Trash

Please remember not to set your trash out any sooner than the night before your scheduled pick up. Encourage your neighbors to do the same. If bagged leaves, clippings or trash are placed out too far in advance, often times they are spilled and the rubbish becomes a real eye sore. RADON

The U.S. Environmental Prosored by the City and the Business -tection Agency (EPA) continues to issue national health advisories about the presence of ionizing radiation in homes, schools, and workplaces. As the natural element radium decays, radon gas is formed in the soil. Radon is a colorless, odorless radioactive gas that is found in structures throughout the country.

> The potential health risk associated with exposure to radon is lung cancer. The U.S. EPA estimates that 16,000 lung cancer cases in the U.S. annually may be attributed to radon.

> The City of St. Matthews has been very proactive in addressing this issue. The City offered 500 radon test kits to residents at a discount price and has implemented Radon Awareness programs. In order to accommodate the widening of I-64 and the Watterson Expressway, portions of Browns Lane Park are currently under construction. Once the changes have been made, this area will be restored and the landscaping refurbished.

RECYCLING ON YOUR HOME TURF




Grass clippings are much more valuable left to decompose on your lawn than in plastic bags buried in our landfill sites. During April and May almost 50% of the annual grass growth occurs in our area. Let's consider recycling clippings as recommended by the local experts, Fred Wiche and A. J. Powell, Jr. from U. K.

- Don't fertilize this spring if you fertilized last fall. Kentuckiana area's grasses are best fertilized twice annually between September and December.
- Set your mower blade to 2" and mow when grass is 3". Removing only 1/3 of the blade keeps grass healthy.
- · Add a mowing cycle. You'll save time not bagging all that grass.
- · Mow only when grass is dry. Wet grass clumps.
 - Keep your mower blade sharp.
