St. Matthews Named Certified City of Ethics

In 2020, the City of St. Matthews was named a Certified City of Ethics by the Kentucky League of Cities (KLC). Certification by the KLC recognizes that St. Matthews has adopted principles and procedures that offer guidance on ethical issues and a mechanism to resolve complaints by constituents.

To gain certification, all elected officials, ethics board members, city attorney, and the city clerk completed intense City Ethics Ordinance training that addressed the six ethics principles governing the conduct of city officials and employees (see sidebar at right).

"Though we've always been ethical, we wanted the citizens of St. Matthews to know that we consider ethical standards a priority," said City Clerk Susan Clark.

Mayor Rick Tonini agreed. "I've served St. Matthews in different capacities through the years and have never seen any action that could be construed as unethical," he said. However, Mayor Tonini remembered a particularly contentious time when some constituents questioned the fair

dealings of the city. "We were considering rezoning a particular area of St. Matthews, and some citizens against the rezoning came to a city council meeting before the item was on the agenda," he said. He explained that before rezoning can be considered by a city, the request must go before the Louisville-Jefferson County Metro government. After that, the city must consider whether to allow the issue to be heard. Because the city had not yet made its decision on hearing the issue, the issue was not listed on the council meeting agenda.

"Because we had not listed the rezoning as an item on the agenda, it would not have been fair to discuss the rezoning issue with those present who were against it when those in favor of rezoning were not at the council meeting to have their say. If we did that, it could be said that we were unduly prejudiced by those who were there," he said, "so we declined to discuss the issue. Those present felt that our reticence to discuss the issue was evidence that the rezoning was 'a done deal,' which was not true at all."

City Audit Concluded

The City's financial audit for June 2019–June 2020 was conducted earlier in 2020. Total General Revenue for that period was \$15,168,289 with total expenses of \$15,080,157. Total assets were \$19,430,201. The City is pleased that the audit resulted in an "unqualified opinion," the technical term for a clean audit.

City Leaders Meet COVID Challenge

2020 was a challenging year for St. Matthews, as it was for every city. Despite extra expenses, the city was able to maintain the high level of services its residents have always enjoyed by employing inventive methods to protect citizens and city employees

during the COVID-19 pandemic. The additional expenses required to continue city services were somewhat ameliorated due to monies made available through Kentucky's Coronavirus Aid, Relief, and Economic Security Act, also known as the Cares Act.

Besides COVID-related expenses, the City incurred further expense to protect its citizens and police officers due to local protests. Notwithstanding, St. Matthews was able to meet the unexpected financial obligations without incurring debt thanks to its leaders' careful management of funds through the years.

The promise of a COVID-19 vaccine gives us hope that we will return to some semblance of former routines in 2021.

Meanwhile, Center for Disease Control guidelines concerning wearing masks and distancing should continue to be followed. City leaders also ask that, whenever possible, residents support St. Matthews businesses and service providers by shopping and hiring locally.

City leaders, along with the Administration, Public Works, and Police departments, look forward to serving residents and visitors in 2021 and working together to meet the challenges ahead with hope, creativity, and the indomitable spirit that has always characterized St. Matthews.

Tree planting

The city will be planting trees in right of way areas around

St. Matthews this spring. Home-owners who request that a tree be planted along a right of way will be responsible for the tree's maintenance. Public Works will offer choices of approved trees or you can plant your own tree at your expense with the approval of the city arborist. Street tree removal must also be approved by the city arborist. If you would like to have a tree planted in the right

of way area in front of your property, call the city at 895-9444. You can also request a tree via the city's website at www.stmatthews.ky.gov. Go to Services, City Public Works, then Tree Program.

Energy Consumption

It's normal to want to crank the thermostat as high as it will go as soon as it gets cold. When you do this, you won't make your home warm any faster and will only be wasting energy. Only raise your thermostat a degree at a time and remember that your thermostat isn't the only thing that can keep you warm.

When you need to get cozy, consider taking these steps first:

- Put on more clothing or cover yourself with a blanket.
- Use heavier, insulated curtains.
- Cook more often.
- Use a humidifier to hold in the warmth.

You can also lower your bill and save energy by buying a programmable thermostat. You can set it to keep the house colder while you are sleeping or away at work, and set it to warm up gradually during the time when you are awake at home.

Police Beat

Fingerprinting Limited and By Appointment Only

As of December 8, 2020, the St. Matthews Police Department stopped providing in-state licensed fingerprint cards because the Commonwealth of Kentucky transferred that responsibility to Identigo, a



private contractor. SMPD will still provide fingerprint cards to individuals wanting non-

state licensed and federal fingerprint cards by appointment only Monday–Friday, 9:00 a.m.–3:00 p.m. To schedule, contact the SMPD at 899-2537.

Certificate Earned

In October 2020, SMPD received the Certificate of Accreditation from the Kentucky Association of Chiefs of Police. The accreditation was approved earlier in the year.

Mobile Data Terminals Purchased

The city purchased 35 new mobile data terminals for SMPD due to wear and tear of some terminals and because the new Windows operating systems was not compliant with the old terminals. The new terminals are faster, can be removed, and are used like a tablet. They also have built in scanners to scan operator licenses. The terminals will

increase officer safety and effectiveness.

STM Ranks 12th in Safety

In November 2020, the City of St. Matthews was ranked the 12th safest city in Kentucky by Safety.com. The ranking is based primarily on the number of crimes committed compared to the total population in St. Matthews. This does not even take into consideration the larger daytime population due to heavily trafficked health services and shopping districts, which makes St. Matthews even safer than their ranking.



New Hires and Promotions

Three officers were promoted to the rank of sergeant in December—Officer Barbara Shepard, Detective John Sanders, and Officer George Jetter.

That same month, SMPD hired two new officers—Officer Jason Hilliard and Officer Brent Routzahn.

Officer Hilliard earned his Bachelor of Science degree in Justice Administration in 2004 from the University of Louisville, where he also played football.

Post-graduation, Jason played six years professional football for the NFL and AFL before joining Louisville Metro as a patrol officer. While patrolling the Newburg area, Jason was the recipient of two Medals of Valor and numerous letters of commendation. Jason also served as a Patrol Training Officer and a division detective.

Jason is married and has two children. He also coaches football at Christian Academy High School.

Officer Routzahn earned a Bachelor of Science degree from Eastern Kentucky University. He joined the Louisville Division of Police in 1996, where he was a patrol officer in the South End. During his 23-year career with Louisville Metro, he has covered most of the metro area as a SWAT, AIR, and Specialty Teams Commander. He has also worked in Public Integrity, Narc/Vice, Burglary, Special Operations, and Special Events.

Brent is married and has two children. Outside of his SMPD work, he coaches sports for his children's teams and enjoys fishing and hiking with his family.

Riot Gear Acquired

Due to the possibility of protests, SMPD has purchased riot gear for every officer, including a riot helmet, gas mask, batons, and body protection.

Crime Trends

St. Matthews is seeing an increase in catalytic converter thefts as well as theft from vehicles and stolen trailers.

Crime Prevention

Follow these tips to avoid being a crime victim:

- Park in a well-lit area.
- Lock your doors on your vehicles.
- Put valuables in your trunk.
- Do not leave vehicles running unattended.

Also remember to use the Internet Exchange Zone in the St. Matthews Police Department parking lot to receive Craig's List and other online purchases as it is in a safe location and is captured on video.

With spring approaching, beware of scams regarding roofing or driveway repair. Always ask for references, and do not let them in your home.

Accident Prevention

Some accidents can be prevented by following this safety advice:

- Do not text and drive—this is currently the highest cause of accidents.
- Clear all windows on your vehicle of snow and frost.
- Be aware that black ice exists in cold weather and leave more distance between vehicles.

When Pam isn't working, she enjoys reading fiction. Recently, she enjoyed novels by Kathleen Brooks, a Lexington author who writes about a fictional town in Kentucky.

Code Words

Construction Activity Requires City Hall Letter

Are you planning an addition to your property? Remodeling? Constructing a new building? Certain steps must be taken before any construction is begun.

Detailed plans and specifications for the construction of new buildings or for an addition to or remodeling of any existing building must be submitted to and approved by the St. Matthews city engineer or his designee. A letter of compliance must be issued before construction can begin. The application for the letter of compliance is available at city hall on the second floor or the link for the letter can be found on the city's website at www.stmatthewsky.gov, under

Business, Permits, within the "Building Permits" paragraph.

The request must be made in person as the requester's signature is needed at the time of issuance. There is no fee for the letter. Depending on the extent of the construction, a building permit must also be obtained from Metro Codes and Regulations under the Kentucky Building Code.

Before St. Matthews can issue a letter of compliance for the construction, all contractors involved, including general and subcontractors, must be identified and have a current business license from the City of St. Matthews. (This is a separate license from the Louisville Revenue Commission and the registration required by Metro

Codes and Regulations.) The application for a business license is available at City Hall or online at our website. An initial license costs \$25, payable by check or cash. Licenses must be renewed annually, and the fee is based upon the year's gross receipts earned within St. Matthews.

Use Trash Bags

Trash for pickup should always be in bags. Cans and bags should not exceed 50 pounds. Please do not place trash at the curb in boxes. All boxes should be broken down and bundled or you can recycle them. Rumpke is not responsible for damaged or missing plastic cans or lids.

Rumpke's yard waste service includes the collection of six 32-gallon cans or bags per pick-up, although this may vary by service region.

Thank you to our residents who are picking up their pet waste in plastic bags when out on a walk. Please remember to carry the waste home with you rather than giving in to the temptation of placing it in another resident's trash bin along the way.

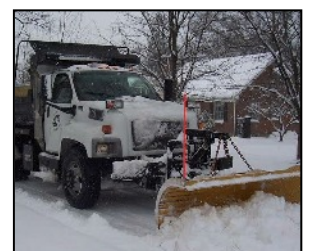
Winter neighbors

When it snows, remove cars or other obstructions from the streets so that Works Department snowplow drivers can get through.

Also remember to keep your walk and driveway shoveled for the benefit of your neighbors, the mail carrier, and other public service workers.

After heavy snowfalls and when sidewalks are icy, St. Matthews residents must carry garbage cans out to the street for pickup. Make sure your garbage can lids are secure and that liquid has not frozen the lid to the can as Rumpke cannot empty frozen garbage.

Especially in winter, remember that garbage cans and recycling containers should not be set out until 5 p.m. the day before pickup, and containers should be put away the same day they are emptied.

Hot Off the Press

Hoarding Increases Fire Risk

If you suspect someone you know is a hoarder, help them understand that their safety and the safety of first responders is being compromised due to fire risk.

First, focus on safety rather than the clutter. Be empathetic. Match the person's language. If they call it hoarding, then you can call it hoarding.

Next, help the person make a home safety and escape plan. Stress the importance of clear pathways and exits. Help that person install smoke alarms and remind them to change the batteries.

Keep in mind that hoarding creates more fire risk due to:

- Flammable items that are too close to the stove or oven while cooking.
- Heating units that are too close to flammable items or are placed on unstable surfaces.
- Electrical wiring that may be old or worn from the weight of piles.
- Blocked pathways and exits that may hinder escape from a fire.

Besides the risk of fire, hoarding impacts first responders because:

- Firefighters cannot move swiftly through a home filled with clutter, and the clutter impedes the search and rescue of people and pets.

- Responders can be trapped in a home when exits are blocked and can be injured by objects falling from piles.
- The weight of the stored items, especially if water is added to put out a fire, can lead to building collapse.
- The clutter prevents first responders from providing quick emergency care.

Two Fire District Team Members Promoted

The St. Matthews Fire Protection District recognized the October 2020 promotions of Sergeant Nick Heilmann to the rank of captain and Bobby Agnew from firefighter to sergeant.

Nick began his volunteer firefighting career with STMFD in

being named captain, Nick earned his Paramedic certification in 2020 after months of tough training. He is married and has two children.

Newly promoted Sergeant Bobby Agnew is a vital member of the St. Matthews Fire Protection District participating on emergency calls, training, station care, and apparatus maintenance. Bobby started his firefighting career at St. Matthews in 2013 and has been reassigned to Station #4 on Westport Road. He is married with one son with another child on the way in 2021.

"We hope that having allowed a third party such as the KLC to look candidly at the practices of the city demonstrates the city's willingness to be transparent," said Councilman Mary Jo Nay. To help create this transparency, not only did the KLC provide training to the city, but it worked with the city to overhaul its Ethics Ordinance, originally enacted in 1996. "The new ordinance is 'beefier,' including guidance regarding social media, among other new topics," said Clark.

Among other directives, the ordinance dictates that city officers and employees of the city or its agencies can't have an interest in a contract made or awarded by the city unless the contract is awarded after public notice and competitive bidding and the city officer has had no part in

awarding the contract, setting bidding specifications, or managing the contract after its award unless the contract has been determined to be in the best interest of the city due to price or limited supply.

The ordinance further stipulates that gifts over \$100

in value cannot be received by city officials and employees whether in the form of money, service, loan, travel, entertainment, or hospitality if it can be inferred that the gift is given to influence that person in the duties of their office.

Further, city officials and employees cannot permit

employees who have personal social media accounts must not mention their government position though they have the option to create a separate social media account as a government official with certain guidelines, which include a prohibition against conducting business through social media. The full ordinance may be found on the city's website at www.stmatthewsky.gov under the Government tab.

To avoid the pitfall of seeming impropriety, city officers and employees with a conflict of interest are required to file a financial disclosure with the city by January 31 of each year. The city's Board of Ethics is the custodian of the financial disclosures. The Board of Ethics consists of 1-5 members, which are appointed by the mayor, subject to city council approval, and serve for a term of three years. They cannot hold any elected office, are not paid, and must be a resident of St. Matthews for at least one year before serving.

The Board of Ethics currently consists of Rev. Raymond Brown, a retired minister of the Protestant, Christian Church (Disciples of Christ), denomination; Joseph Buddell, the former mayor of Cherrywood Village until its annexation by St. Matthews in

people to use city time, funds, personnel, equipment, or real property unless that use is authorized by the city and follows the same guidelines for use by the general public.

One of the newer parts of the ordinance addresses social media. City officials and

2000; and Kevin Garvey, a retired judge having served on the District and Circuit Court bench for 29 years.

The Board of Ethics is also responsible for ruling on the violation of the city's Ethics Ordinance, which is considered a Class A misdemeanor and is punishable by a fine up to \$1,000, disciplinary action, and the repayment to the city of any economic gain or benefit realized from a violation of the Ethics Ordinance. Contracts that are

received in violation of the ordinance are voided.

Complaints alleging a violation of the ordinance are made in writing to the Board of Ethics. Unless the complaint is dismissed due to lack of factual basis, a hearing is held to determine if the officer or employee is in violation of the ordinance. Complaints must be made within a year after the alleged violation is discovered.

"The Ethics Ordinance was originally put in place because the

City of St. Matthews wanted its constituents to know that its first priority was to conduct all government business in an ethical manner," said Mayor Tonini. "With the Kentucky League of Cities' certification, we saw an opportunity to demonstrate what was already true to our constituency—that the bedrock of any decision made by their city officials and employees is a code of ethics clearly demonstrated in its every act and action."

Your Works At Work

Snow Removal

The City of St. Matthews operates a comprehensive snow removal program. With smaller snow events, to be fiscally responsible, the city will only salt the inter-sections. All major roads, including Shelbyville Road, Westport Road, Hubbards Lane, Browns Lane, Bowling Boulevard, and Breck-enridge Lane, are the responsibility of Louisville Metro and the state.

Since the last newsletter, the following has been accomplished:

Completed Projects

- Picked up leaves in the fall, despite fewer personnel due to COVID restrictions.
- Cleaned public restrooms daily to meet COVID restrictions.
- Completed drainage project on St. Germain.
- Completed drainage project on Winchester.

- Repaired sidewalk in 300 block of Hemmingway.
- Cleared and trimmed multiple alleys and drainage ditches in Warwick area.
