St. Matthews Police Now Has Full-Time Victim Services Specialist

The St. Matthews Police Department has recently moved Carolyn Estep, their contract Victim Services Specialist since December 2021, to a full-time position in the department, to better serve the department and the public. Victim Service Specialists are responsible for supporting victims through the prosecution of a criminal case and facilitating their participation in the criminal justice process. Carolyn, who is a licensed therapist, contacts victims of crime to offer assistance, such as walking them through the process of an emergency protective order, locating therapy for domestic violence, or referring them to other agencies that can provide the help they need.

Chief Barry Wilkerson said that the duties of the position have been expanded. "When we first hired Carolyn, we were looking to see how it would benefit the citizens of St. Matthews. Thanks to the training and her networking with other cities and agencies, we have expanded what we can offer to the public."

Chief Wilkerson says that having a victim services specialist actually lessens the number of runs police have to make. For example, in the case of a mental health crisis, instead of the police coming out on multiple calls, Carolyn can come out with them on the initial visit, assess the situation, and get them in touch with agencies and others who can help them. Chief

Wilkerson says, "As officers, we are often limited in what we can do. Our goal is to solve problems, not just arrest people. Carolyn is a liaison to get problems resolved."

Carolyn says what has changed in the past year and a half since she started with St. Matthews is that the Victim Services program has grown."Our residents now recognize that we offer this service. All of our officers are trained in crisis intervention, as well as me, and we can now better assist persons having mental health crises. Our goal is not to criminalize someone who is having a mental health issue, rather, we want to get them in touch with community-based resources. Often, they do not need police, they need someone to help them navigate the system."

For example, Carolyn is currently working with a crime victim, who has a four-month-old baby, and only speaks Spanish. She is accompanying her to help her get translators and find her way through the court system. Carolyn said the needs are as varied as the situations themselves. After Carolyn learned of an elderly couple that could not call for help when their landline was out during a storm, she procured several 911—only cell phones to give to people in this type of situation.

Carolyn states that the police officers

have embraced her work, saying, "The officers are very compassionate about people that they encounter and come to me to find resources for them."

Chief Wilkerson adds, "A police officer accompanies Carolyn on every run that they make, to make sure that each situation is as safe as possible."

In order to learn the latest in best practices, Carolyn has been networking with other victim services specialists in other counties and cities. They meet once a month via Zoom to exchange ideas and information.

Carolyn said she attended a Mental Health Summit in Louisville at the end of May and there were people from all lines of work there—judges, attorneys, jailers, hospital workers, police, who all

2023-24 Budget for City Passes

The City of St. Matthews has passed ordinance #23-02, adopting the annual budget for the fiscal year of July 1, 2023, through June 30, 2024, estimating revenues and resources and appropriating funds for the operation of city government, in the amount of \$\$22,071,526. In addition to adequately appropriating for the operation of city services, such as Police, Public Works, Administration, and IT, within the budget are appropriations for capital improvements to our parks system, in particular, adding and upgrading the electricity within Brown Park, additional restrooms in Community Park, stream bank stabilization in Draut Park, and adding new basketball and pickle ball courts in Warwick Park. It is the goal of the Mayor and City Council to continually maintain a high level of quality of services, an inclusive and inviting park system, a welcoming environment to our visitors, and a splendid city for our residents to live in.

Good Neighboring

Reduce your speed. Kids are going back to school, so watch for walkers and bicyclists, and those loading and unloading from school buses.

Don't block sideways with trash containers or vehicles, which obstruct



the way of pedestrians, particularly those with disabilities.

Keep pets on a leash, it's the law. Pick up after your pet while off of your property, and don't allow your dogs to bark excessively.

Confirm that your house number is visible from the street so that first responders can locate you quickly in an emergency. Numbers should be a minimum of 3 inch in height, should be posted close to the front door of your home, and lit after dark, if possible. Seconds in an emergency can be lifesaving.



Updates from St. Matthews Police Department

Active Shooter Training

In response to recent tragic events that have taken place in Nashville and in Louisville, the St. Matthews Police Department has been asked to provide information and training in response to an active shooter event. Representatives from SMPD have conducted site assessments and provided training to many businesses in the St. Matthews area and various locations nearby. DEA National Prescription Drug Takeback Day

The St. Matthews Police Department once again participated in the DEA National Prescription Drug Takeback Day. In previous years, the only collection location was the Kroger Store on Hubbards Lane. This year, we expanded our participation to include a second collection point at Baptist Health Hospital. Officers from SMPD, along with employees from Kroger and Baptist Health accepted unneeded prescription medications as a measure of preventing medication misuse and opioid addiction from ever starting. With the expanded program, the St. Matthews Police Department was able to collect and dispose of 418 pounds of unneeded prescription drugs at the two locations. The St. Matthews Police Department accepts unneeded prescription medication Monday through Friday 8:00 am-4:00 pm at the police station lobby located at 3940 Grandview Avenue.

Flock Cameras

The St. Matthews Police Department is in the process of installing Flock Safety[®] cameras throughout the city. These


cameras are capable of reading license plates and capturing images of each vehicle that passes by certain locations.

The St. Matthews Police will maximize neighborhood and citywide security with Flock Safety® License Plate Reading Cameras. License plate reading cameras work because roughly 70% of all crime is committed with a vehicle. So, whether it's vandalism, theft, or other suspicious activity, Flock Safety's technology quickly and objectively identifies a suspect's vehicle, enabling us to track criminal activity more effectively in our area. More importantly, Flock Safety® helps neighborhoods and law enforcement to work together to capture the evidence needed to reduce crime rates, improve neighborhood security, and protect home values. Our cameras, along with hundreds of thousands of other cameras in our region, are able to be integrated into one database, allowing our officers to track vehicles across the region and nation.

LEPP Grant Announcement

The St. Matthews Police Department was awarded three grants from the Law Enforcement Protection Program (LEPP) totaling \$193,730.00. With these awards, the department was able to purchase new Tasers, duty weapons and short barrel rifles for SWAT.

This is a direct tax savings to the City of St. Matthews and the citizens we serve. The new Tasers replaced our seven-year-old Tasers that were experiencing display failures. The new Tasers are a high visibility yellow, in contrast to the old black Tasers. This allows for easier recognition of the Taser by officer and citizen, thus reducing the confusion



The second LEPP grant was for replacement of the officer's duty weapon and ammunition for training on the new guns. The officers of the SMPD carried the 9mm Glock model 19. These handguns were replaced with the 9mm Glock model 45 MOS. The Modular Optic Systems (MOS) simplifies the mounting of an optical sight which produces a red dot for target acquisition. Optical sights improve the accuracy at both long and short range, enabling faster target transition and quicker sight acquisition of the target. Each officer has received 16 hours of training to become proficient in the use of the new firearm and optic sight.

The third grant that SMPD received was for the purchase of a Geissele rifle package that is designed for our SWAT Team. The rifles replace our current SWAT rifle and will allow for those rifles to be assigned to patrol officers and begin a patrol rifle program for all our patrol officers. The grant provided ammunition for training and every officer carrying a patrol officer rifle will be fully trained on the weapon.

Team Training Produces Coordinated Response

There have been over 250 mass shootings in the United States so far this year according to the online Gun Violence Archive. That's why first responders in St. Matthews enthusiastically arranged to train their staff for any active shooter incident.

Fire Fighters with St. Matthews, Anchorage Middletown, their EMS units, and officers with the St. Matthews Police Department teamed up recently to synchronize efforts to keep our community safe.

These First Responders trained together to ensure a coordinated response in an

event of an active shooter or related incident. This Rescue Task Force worked through various scenarios learning each other's tactics and procedures.

The time to understand how these agencies will work side by side, performing under hazardous and stressful conditions, with precision and ability in the event of an extreme emergency, must occur before an incident arises. Each agency plays a critical role in protection to our citizens; therefore, the importance of training cannot be ignored.

Back To School Safety Tips

School days bring increased traffic and road congestion. School buses are picking up students, kids on bicycles, harried parents dropping their kids off at school and hurrying to work. It's never more important for drivers to slow down and pay attention than when kids are present—especially before and after school.

Safety Tips:

- Stay alert and avoid distracted driving.
- Watch for children.
- Obey school zone speed limits and follow your school's drop-off procedures.

- Children pay attention to and obey the school crossing guards.
- Never pass vehicles stopped at crosswalks.
- Never pass a bus loading or unloading.

The biggest risk regarding school buses is children approaching and exiting the bus. Often children do not remember to follow the best safety practices, so it is up to the motorists in the community to keep safety in mind.

If you leave for work in the morning when children may be on their way to school or the bus stop, be sure to drive



more carefully when pulling out of your driveway and leaving the neighborhood.

Community Center Park

McCandless Field has just received a new synthetic infield (\$185,000). This investment will virtually eliminate rainout games and provide a major league experience for all ages. All of the out buildings in the ball park (dugouts, press boxes, concession stands) have received a fresh and new look.

The city will be installing a new permanent restroom in the vicinity of McCandless Field, eliminating the remaining portable restrooms.

A newly renovated rain garden is located at the back edge of the rear parking lot to actively filter contaminates during storm water runoff. It is important to reduce pollution from road salts, vehicle oil, gas, and other lubricants, before they enter the nearby stream in the park.

The interior renovation of The Arterburn building has been completed. An update to the front façade is to be performed this year, giving the building a fresh new look.

Arthur K. Draut Park

The City is investing, nearly one million dollars, in a project that will stabilize the stream banks of Beargrass Creek that runs through the park. This work will eliminate the continued erosion as a result of frequent large storms. The project will also include the removal



of sediment that has collected in the saddle basins that hold water, resulting in deeper water storage areas, which will assist during flooding occurrences and prevent the growth of the invasive cattails.

Reminder: All of our City Parks are equipped with pet waste disposal stations. Please clean up after your pets.

Hometown History

Notable Area Founder—Joseph Oechsli

In 1893, Joseph Oechsli (pronounced Exly) purchased the house and property of Dr. John Nichols Lewis, a physician in St. Matthews who died in August 1878. The Lewis property extended to Shelbyville Road and included land that the Grimes family had owed since the 1930s when Abraham Grimes, an early postmaster, lived in a log house. Some frontage, along Shelbyville Road, was provided for the Greathouse School.

Mr. Oechsli farmed the 37 acres before, at age 75, he decided to give up farming for the life of a developer. In 1927, Oechsli subdivided a significant part of his potato farm as Excella Place, The Joseph Oechsli Tract. Excella Place was comprised of Brown and Ridgway Avenues from Westport Road to Shelbyville Road, with Oechsli Ave running east to west, intersecting those streets. The advertising for Excella Place touted it to be: St. Matthews Subdivision—Beautiful, The Most Attractive, Convenient and Desirable Location Around St. Matthews. An Exclusive Home & Residence Location, and boldly highlighted: No Railroads or Highways to Cross—Children are safe in going to or coming from school or church.

It's noteworthy that Mr. Oechsli's advertising approach also included that Excella Place would have: City Conveniences, Water, Electric Lights, Streets and Sidewalk, but NO CITY TAXES, in addition to claims that the streets within the Excella Place development would be built to last.

For a sales office, he acquired the old post office on Chenoweth Lane, near the railroad station that had been converted into Crowder's barbershop, moving the small frame structure to his Ridgeway Ave home, where it remains still today.

Joseph Oechsli died in late 1935 at the age of 83. The house, which still stands today, is located at 4070 Westport Road, on the southwest corner of Ridgway Avenue and Westport Road, and is home to the Atteberry Smith retailer.

Code Words

In November of 2019, the St. Matthews City Council found it necessary to provide for safeguarding the health, safety and welfare of the people by requiring the maintenance of property or premises in good and appropriate condition, and to enhance the economic value of the community and each area in it, through the regulation of the maintenance of property and premises.

In furtherance thereof, and for the purpose of reducing the threat to health, safety, welfare, appearance and economic value due to the decline in property condition(s), Chapter 94 of the St. Matthews Code of Ordinances delineates the circumstances under which such condition(s) may be considered illegal and/or require abatement, and further allows for abatement of such conditions, if abatement is in the best interest of the health, safety and welfare of the residents of the city.

After defining many terms in Section 94.01, Section 94.02 identifies specific property maintenance standards. Many of these standards already existed in prior city ordinances and were restated herein. Some new standards with which people may not be aware are ones dealing with building maintenance issues. Prior to the adoption of these standards, only the Louisville Metro property maintenance standards were

applicable in St. Matthews, and code enforcement did not have authority to enforce the Metro ordinances.

Standards now enforceable by St. Matthews include keeping windows, exterior doors, porches, roofs, eaves, foundations, exterior walls, and exterior stairs in good repair by ensuring they are watertight, weathertight, bird, animal, rodent-proof and kept in sound condition. All exterior wood surfaces other than decay resistant woods, must be protected from the elements and decay by paint, or by other protective covering or treatment. Peeling paint is a violation of this section. Gutters, shutters, down spouts and other parts of the exterior of the house must be

maintained in their original condition and fit for their intended purpose.


Finally, should any person receiving notice of violation of these standards fail to correct the situation and/or ignore the notice, cumulative fines may be assessed against the property owner, with each day during which any such offense is committed, continued or allowed being a separate offense. The fine for the first offense is \$50 and increases each day the violation continues to a maximum of \$6,000. We happily note that the vast majority of our citizens never reach the stage requiring a fine, and readily correct the situation once they are notified.
