## St. Matthews to Celebrate 75 Years as a City, over 265 Years as a Community

On March 22, the city of St. Matthews will have realized 75 years as an incorporated city and over 265 years as a historic community. ### Hometown History—St. Matthews Mayor Bernard F. Bowling (1958-1984)

Bernard Bowling, Sr. was appointed mayor in October 1958 when failing health forced James Noland to resign. Bowling was a long-time St. Matthews businessman and civic leader whose family owned Plehn's Bakery at 3940 Frankfort Avenue. However, he was also trained as a civil engineer, and it was that technical expertise that proved important when he tackled the city's chronic drainage and flooding problems, which had historically been the biggest obstacle to development in St. Matthews.

Bowling quickly initiated a \$2 million sewer-construction project that laid the groundwork for developing the bulk of the city's remaining undeveloped land, and thus for phenomenal growth in the city's tax base during the 1970s and 1980s.

Bowling, a father of 10 children, served as mayor for 26 years, without pay for the first 21; he was personally involved in virtually every decision, large and small, made on the city's behalf over more than a guarter-century. He spent thousands of hours driving and walking the neighborhoods and came to know St. Matthews like the back of his hand. "I know where every sinkhole is," he once boasted. He also made a point of knowing almost every homeowner and business person by name. His unrivaled devotion to the city's welfare and his considerable personal charmnot to mention his careful cultivation of the like-minded City Council and administrative staff-gave Bowling the authority to conduct the city's affairs almost single-handedly.

Determined to maintain cordial relations with larger local government entities (mainly to safeguard his city's independence), he had doughnuts delivered from his family's bakery to Louisville City Hall and Jefferson Fiscal Court virtually every day he was in office. Some critics contended that Bowling was excessively prodevelopment,



and that his zoning policies in particular led to "piece-meal development of large tracts of land," causing traffic congestion and spoiling the city's quiet residential character.

Bowling believed he had done what was necessary for St. Matthews to prosper and to continue meeting the needs of its citizens.

Gretchen Kaiser, a former city clerk once said, "The thing about Mayor Bowling was that he really loved St. Matthews; that was obvious even to the people who disagreed with him. He had a very specific vision of the city's future, and he made it happen. The St. Matthews we live in today is largely the one he envisioned.



## Springtime Crime Prevention Tips

As spring approaches, people tend to spend more time outdoors, travel for vacations and engage in spring cleaning and home improvement activities. This increase in activity can present new opportunities for criminals, so it's important to take proactive steps to prevent crime during the spring season. Here are some springtime crime prevention tips:

#### Enhance Home Security

- Secure windows and doors: Spring means warmer weather, and many people open windows or doors for ventilation. Ensure all windows and doors are properly secured when not in use. Install window locks and consider using security bars or screens if necessary.
- Maintain a well-lit property: Install motion sensor lights around entrances and dark corners of your property to increase visibility.

#### Keep Your Lawn and Garden Secure

- Maintain a tidy yard: Keep your grass mowed, hedges trimmed, and bushes near windows pruned.
- Secure garden tools and equipment: Store these items in a locked shed or garage.
- Consider installing a fence or gate around your property.

#### Be Aware of Seasonal Crime Trends

- Watch out for open door opportunities: Always close and lock doors and windows when you leave, or are working out in your yard.
- Stay vigilant for porch pirates: Consider using a secure delivery location or porch camera.

#### Prepare for Seasonal Events

- Festival and event safety: Be aware of your surroundings and keep belongings close.
- Lock your bike and other outdoor gear: Secure all outdoor equipment.

### Fire Safety Tips

It's important to act quickly if your car catches fire.

#### If your vehicle catches fire:

- Pull over as quickly as you can when it is safe.
- Once you have stopped, turn off the engine.
- Get everyone out of the car. Never return to a burning car. Do not try to fight the fire yourself.
- If you think there is a fire under the hood or trunk, do not open it. This could cause the fire to grow.
- Move everyone at least 100 feet from the burning car and well away from traffic.
- Call 911.

#### To prevent a vehicle fire:

- Have your car serviced regularly by a trained mechanic.
- Keep gas cans or propane tanks away from passengers. Tightly seal and place them on a flat surface to make sure they stay upright.
- Keep windows open to stop fumes from building up if you must put gas cans or propane tanks inside your vehicle.
- Drive safely to avoid an accident.

# Code Words

## Code Enforcement Board Established in St. Matthews

In September 2024, St. Matthews created a Code Enforcement Board to protect residents' health, safety, and welfare through an administrative mechanism for ensuring municipal ordinance compliance.

The board is comprised of three active members and two alternates who:

- Must be residents of St. Matthews for at least one year.
- Must be at least 21 years old.
- Will be nominated by the mayor and confirmed by city council.

#### **Board Operations**

Regular meetings will be held at City Hall, 3940 Grandview Avenue, at 6 p.m. on the first Tuesday of each month if there is business to be undertaken. Additional meetings will follow Kentucky Open Meetings Act requirements.

#### Key Powers

The Code Enforcement Board can:

- Conduct hearings to determine ordinance violations.
- Issue remedial orders for code breaches.

- Impose civil fines for violations.
- Establish municipal liens for unpaid fines and enforcement costs.

#### **Enforcement Details**

The board may levy fines against property owners found in violation, with the city retaining the right to place liens on properties to recover enforcement expenses.

Residents interested in the board's work are encouraged to review the complete ordinance (24-04) on the St. Matthews website's Code and Ordinance Page.

## Since the last newsletter, the following has been accomplished:

#### **Completed Projects**

- Warwick Park Phase I: New basketball and pickleball courts now open
- Leaf Collection: Crews collected leaves from city right-ofways.
- Seasonal mowing of parks and public spaces completed
- Street pot holes patched.
- Foliage cleared from undeveloped alleys in Camelot and Warwick neighborhoods. Residents are responsible for maintenance of the property in the front and rear of their properties.
- Storm debris removal.
- Tree stump removal from storm-damaged and permitted sites.

#### Ongoing and Future Projects

- Trinity Hills Ditch Drainage Improvements: Construction in progress, scheduled for completion June 30, 2025.
- Draut Park Stream and Basin Improvements: Bidding process underway, phased construction expected this winter.
